Gift Sales Policies & Procedures

2018-2019 Season

Admission and Rental Costs:

With Gift Sales purchases, adults (any patron over 58 inches tall) are admitted for \$6 each. Children (any patron under 58 inches tall) are admitted free of charge. Skate rentals are available for \$6 per pair for children and \$12 per pair for adults. Gift Sales may be processed for any admission and/or rental ticket, season or multi-visit passes, or gift cards. Gift Sales requests must be received at least seven days prior to the requested pickup date. Request forms must be submitted with payment.

Financial Arrangements:

Payment in full is required by not less than seven days prior to the requested pickup date. Orders will be given only to the purchaser or designated pickup person. The various types of admission/rental passes are: admission-only; rental-only (for children); and combination (admission + rental) passes. Other available passes are Individual (single person) or Family (2 adults, 2 children) Season Passes, Lunchtime Season Passes (valid weekdays 12-2pm only), and 10-Punch Admission Cards. Gift Cards may be loaded with any amount you choose and are valid at the ticket booth as well as the snack bar. All tickets/passes are NON-REFUNDABLE.

Rink Closures:

All rink closures (due to inclement weather, etc) will be announced via www.bostonfrogpond.com, our Facebook page (FrogPondBoston), and our Twitter account (@FrogPondBoston). Guests are encouraged to check these sources prior to visiting.

Alcohol:

Alcoholic beverages are prohibited in the Boston Common.

Smoking:

Smoking or vaping of any substance is also prohibited in the Boston Common.

Café:

The facility's café is open during all public skating sessions. Outside vending or catering is not allowed at the rink. Café items must be paid for directly to the snack bar.

Parking:

Parking is available in the Boston Common Parking Garage, located directly under the Boston Common with an entrance on Charles Street (between Boylston and Beacon Streets). Parking fee information is available from the garage.

Release of Liability:

Guests skate at their own risk. The organizer understands that this activity presents and involves inherent risks, including injury or death. The organizer will notify their guests of these risks and all guests will voluntarily agree to expressly assume all risk of injury and death that may result from participation in this activity, related in any way to the use of this facility.

Conduct:

To ensure the safety and enjoyment of our guests and clients, no unsafe or disruptive behavior will be tolerated on the premises. Intoxicated persons will not be permitted. No hockey sticks (or other equipment), electronic devices, or props are allowed on the ice. The Boston Common Frog Pond skating rink has the responsibility and the authority to exclude events inappropriate to the facility.
