## **Boston Common Frog Pond**

### Monday Night Rink Rental

2022-2023 Season

#### **Rental Cost:**

The cost of renting the Frog Pond for private ice time is \$2000 for one and a half hours, or \$3500 for three hours. This fee is for ice time only, and must be paid in full to hold the reservation. Skate rentals and lockers are additional and may be paid either by individual guests or by the event organizer. If a skating instructor is desired, this must be indicated when reserving your rink rental and is subject to availability. Instructors may be arranged for basic skating assistance only - no advanced lessons.

#### Cancellation:

In the event of rink closure due to inclement weather or other unforeseen circumstances deemed necessary by rink management, a full refund or rain date (if available) will be issued. Under no circumstances will a refund be issued to the client for other reasons.

#### Alcohol/Smoking:

Alcoholic beverages and smoking/vaping of any substance are prohibited at the Frog Pond and throughout the Boston Common.

#### Café:

The Frog Pond Café will remain open for all Monday Night Rentals. Outside vending or catering is not allowed on the premises. All charges incurred are due either directly to the snack bar at the time of purchase, or at the close of the event if the organizer is paying for items ordered.

#### Parking:

Parking is available underneath the Boston Common in the Boston Common Parking Garage at 0 Charles St, between Boylston and Beacon Streets. Rate information is available from the garage.

#### Release of Liability:

Guests at the Frog Pond skate at their own risk. The organizer understands that the activity of skating involves inherent risks, including injury or death. The organizer agrees to notify their guests of these risks, and that by entering the premises, they are voluntarily agreeing to expressly assume all risk of injury and death that may result from their participation in this activity related in any way to the use of this facility.

#### **Conduct:**

To ensure the safety and enjoyment of all of our guests and clients, no unsafe or disruptive behavior will be tolerated while on the Frog Pond premises. Intoxicated persons will not be permitted. No hockey sticks (or other equipment), electronic devices, or props will be allowed on the ice. The Boston Common Frog Pond has the authority and responsibility to remove disruptive guests from the premises and to prohibit inappropriate behavior.
